GOLF BY-LAWS

I. SCHEDULE

DUAL: ROUND ROBIN IN DIVISION

CONFERENCE: GIRLS/PRE-SEASON TOURNAMENT
BOYS/PRE-SEASON TOURNAMENT

II. DAYS TO BE SCHEDULED

TO BE DETERMINED BY INDIVIDUAL SCHOOLS BASED ON COURSE AVAILABILITY. LEAGUE SCHEDULE WILL SHOW TUESDAY AND THURSDAY MATCHES. THE BOY'S AND GIRL'S SCHEDULES WILL MIRROR EACH OTHER DURING THE FALL AND SPRING SEASON.

III. NUMBER OF PLAYERS

PLAY 6...COUNT 4

IV. CHAMPIONSHIPS

DIVISIONAL:

CHAMPIONSHIP WILL BE AWARDED TO THE TEAM WITH THE MOST ACCUMALATED POINTS FROM THE SINGLE ROUND ROBIN SCHEDULE, THE CONFERENCE TOURNAMENT AND ASSOCIATION OURNAMENT. EACH WIN IN THE REGULAR SEASON WILL COUNT AS 1 POINT, 0 POINTS FOR A LOSS. IF A TIE SHOULD OCCUR, THE SCORES OF THE 5th PLAYER SHALL BE USED AS THE FIRST TIE BREAKER, THE 6th PLAYER AS THE SECOND TIE BREAKER. THE TEAM WITH THE BEST FINISH IN THE CONFERENCE TOURNAMENT AND THE ASSOCIATION TOURNAMENT WILL RECEIVE 6 POINTS, 2ND WILL RECEIVE 5 POINTS... IF A TIE RESULTS FOR SPOTS 1-6, THE SAME TIE BREAKER WILL BE USED AS WITH THE DUAL MEETS.

CONFERENCE:

THE CONFERENCE CHAMPION WILL BE THE TEAM WITH THE MOST COMBINED POINTS FROM THE CONFERENCE PRE AND POST SEASON TOURNAMENTS. FIRST PLACE WILL RECEIVE 13 POINTS, SECOND PLACE WILL RECEIVE 12 POINTS AND SO ON.

SCHOOLS WHO DO NOT HAVE AT LEAST 4 PLAYERS MAY NOT COMPETE FOR A TEAM CHAMPIONSHIP BUT MAY PARTICIPATE IN THE PRE AND POST SEASON TOURNAMENT FOR INDIVIDUAL RECOGNITION.

TOURNAMENT SITES:

THE PRE-SEASON AND POST- SEASON WILL BE AT A NUETRAL SITE AS DETERMINED BY THE LEAGUE COACHES.

V. ALL CONFERENCE AWARDS:

ALL CONFERENCE AWARDS WILL BE GIVEN TO THE TOP 16 ATHLETES WHO FINISH WITH THE MOST POINTS IN BOTH THE PRE AND POST TOURNAMENT AND THE CONFERENCE TOURNAMENT. IF A TIE EXSISTS BETWEEN TWO OR MORE PLAYERS FOR THE SIXTEENTH SPOT, A SCORECARD PLAYOFF WOULD BE CONDUCTED USING THE TOTAL OF THE TWO HIGHEST AND THE TWO LOWEST HANDICAP HOLES. TWO ADDITIONAL PLAYERS WOULD BE SELECTED BY THE COACHES TO ROUND OUT THE CONFERENCE TEAM, 18 ATHLETES PER CONFENCE.

TEAM AWARDS:

DIVISIONAL.....PERMANENT AWARD (2)
CONFERENCE.....PERMANENT AWARD (1)

VII. IN THE EVENT OF A RULES DISAGREEMENT, THE MATTER MUST BE SETTLED PRIOR TO DEPARTING THE GOLF COURSE. THE COURSE PGA PROFESSIONAL SHOULD BE INCLUDED IN RENDERING A DECISION.

VIII. MHSAA RULES SHALL BE FOLLOWED.
